DATA MANAGEMENT PROJECT OVERVIEW

Haventree Bank is a federally regulated Canadian bank that provides alternative mortgage programs and insured GIC deposits, so they must regularly secure, manage and maintain information. Previous solutions were manual processes and an older EDRMS system which required end users to review, track and manage information. As the on-premise email archive approached its end-of-life, the IT and RM departments teamed up to implement Collabspace, a cloud solution that would allow them to sunset old systems, create less dependency on manual processes, automate current record review processes and ensure compliance to industry and regulatory standards. This presented a great opportunity for the organization to move to the cloud with a new solution that provided email archiving and records compliance.
